



COMMUNITY ENGAGEMENT AND COMMUNICATIONS STRATEGY







Community engagement and communication are key to fostering child care readiness by building involvement, awareness, and support. Without clear communication, the importance of child care as a community priority can be overlooked, leading to missed opportunities for collaboration and progress.

This communications strategy will ensure that messages reach the right audiences with clarity and impact. It provides a roadmap for building relationships, driving engagement, and securing

support for child care-friendly initiatives. Additionally, this strategy will guide how communities engage with key partners, such as local governments, child care providers, and families, while offering examples of messaging across various channels like social media. community forums, and newsletters.

PURPOSE

This communications strategy was developed to provide comprehensive support to communities in enhancing their public outreach efforts, which includes maintaining ongoing communication channels. By actively engaging with community members, it facilitates a collaborative approach to address and meet the unique child care needs specific to each community.

Engagement and communication needs vary widely from place to place, so this strategy should be used as a framework, and communities should implement elements that will work for them.

KEY PARTNERS

Every community has different needs, and the key partners identified will reflect this diversity, encompassing a wide range of perspectives and expertise to address the unique challenges and requirements specific to each locality. By engaging various groups, the policies developed will be more comprehensive, inclusive, and tailored to effectively meet the distinct needs of the community. Below are examples of important interest holders and partners, and how to identify them in your community:

- Parents. Engaging parents directly ensures that the policies reflect the needs and preferences of the families who will benefit from them. Parent focus groups, surveys, or town hall meetings can help gather a diverse range of opinions and needs.
- Child Care Providers. Child care providers is a wide umbrella that encompasses a wide range of individuals or organizations that provide child care or child care support. Examples of providers may include business owners who operate child care centers, non-profits that may run child care operations or support child care operations, workers who provide care and educate. Providers offer insight to the operational, regulatory, and financial challenges of running a facility. Their experiences are vital for shaping practical, on-the-ground solutions.
- Residents. Engaging residents in child care initiatives is important because it helps to create a community that is supportive of young children and their families. When residents are actively involved, it leads to a more inclusive, effective, and sustainable child care ecosystem.
- Early Childhood Non-Profit Organizations and Advocacy Organizations. Child care advocacy groups are crucial in understanding the needs of families and the workforce. These organizations often work directly with families and can provide data, research, and insights to shape effective policies. Local non-profits with a focus on education, family services, or community development can also be valuable partners.

For every group, it is important to identify key individuals to receive tailored information. Every audience will need to have optimal communication formats. Some forms of communication will cross segments of various audiences and others will be niche to an individual group. The key is to segment the audience based on their needs. An example of some key messaging for distinct partner groups is provided in the table.

ADDITIONAL RESOURCES

- Regional Child Care Coalitions. Connecting with the regional child care coalition that encompasses your community is an important way to stay connected to the wider network of child care support. Maintaining ongoing communication is also a good way to stay connected to funding opportunities or early childhood initiatives.
- Culturally Specific Community-Based Organization. Community-based organizations (CBOs) are organizations that tailor their programs, services, and outreach efforts to meet the unique cultural, linguistic, and social needs of a specific cultural or ethnic community. These include religious organizations, which frequently offer child care in conjunction with the other community services they provide. These organizations are important to engage as child care providers, but also as community advocates.
- Public and Private Schools. Schools play a critical role in early childhood education and care transitions. Engaging with both public and private educational institutions ensures alignment with local educational goals and facilitates a smoother transition for children entering kindergarten and beyond.
- Major Employers. Large employers have a vested interest in ensuring that their workforce has access to reliable child care. Partnering with employers can lead to collaborative efforts such as employer-sponsored child care programs or financial investments in local child care infrastructure.
- Economic Development Organizations. These organizations can help connect child care needs with broader economic growth strategies, ensuring that affordable, high-quality child care is seen as an integral part of workforce development and attracting businesses to the area.
- Community-Based Early Childhood Organizations. These local organizations focus on supporting early childhood development within a specific community. These organizations provide a variety of services and programs designed to support young children and their families.
- Chambers of Commerce and Other Business Associations. Providing adequate child care is inherently a business concern, as lack of child care can lead to workforce challenges and higher job turnover. Because of this, business associations and chambers of commerce have a vested interest in promoting child care and may be an important key partner to engage.

COMMUNICATION CHANNELS

Communities have multiple channels available for communicating with residents, businesses, and other partners. Utilizing a range of channels can enhance participation and awareness. Some examples of messaging channels are provided below, though communities are encouraged to explore creative ways to leverage their communication resources.

- Community Forums and Meetings: In-person or virtual gatherings for public input and discussions.
- Email Newsletters: Direct communication with residents for announcements and updates.

- Mobile Apps: Provide access to city services, alerts, and reporting tools.
- Official Websites and Portals: Central hubs for municipal information, services, and updates.
- Press Releases and Media Relations: Work with local media outlets to disseminate information.
- Public Access TV and Radio: Broadcast city meetings, updates, and educational content.
- Social Media Platforms: Use for real-time updates, community engagement, and outreach campaigns.

KEY MESSAGING

While messaging will vary depending on the audience, consistency across all communication channels is crucial. In policy discussions, communication often begins by focusing on the problem, which can fail to provide a full understanding of the issue's root causes and may overlook opportunities to deepen public awareness.

This strategy adopts a proven technique to steer conversations toward solutions. By starting with the principle that child care should be more accessible, followed by identifying challenges and presenting opportunities, this approach is more effective in gaining greater buy-in and support.

While this guide provides sample language, often the most effective form of communication centers on personal experiences. Policy makers and users of the guide are encouraged to include their own experiences and support for child care. Beyond what is offered in this guide, policy makers should respond to current reports, research, and events involving access and the cost of child care.

OPPORTUNITY 1: Understanding Child Care as Infrastructure

- Providing an understanding about the importance of child care facilities can help create a supportive community for future action and investment.
- Explaining that child care is a piece of invaluable infrastructure helps frame it as a public good, and that it should be funded as such.
- Comparing child care to other infrastructure like roads and public schools can help create the necessary public and political will to invest in the future of the community.

MESSAGE: "Child Care is Infrastructure: Why Communities Can't Function Without It"

We often think of infrastructure as roads, bridges, and public schools—essential services that keep our communities functioning. But what if we told you there's another form of infrastructure that's just as critical? Child care is infrastructure, and without it, our communities and economy simply cannot function.

Creating support and encouraging child care facilities in your community requires a multifaceted response.

Every community faces different challenges; therefore, the menu of communication options should be selected based on the need you are trying to address. The following examples of key messaging have been broken into broad opportunities with a variety of messaging types within each topic. The example language is designed to help develop clear and consistent messages for each audience. Creating a schedule for when key communications will occur can help make sure partners receive information at every step of the process.

Think about

it: high-quality, affordable, accessible child care allows parents to work without the constant stress of worrying about their children's safety and development. This is especially true for working mothers, many of whom face the difficult choice of either continuing their careers or staying home due to the high cost or unavailability of child care. Without reliable child care, parents are forced to make sacrifices that can stall their professional growth and place additional pressure on household finances.

But the value of child care doesn't stop at the family level. When communities invest in child care, they create opportunities for economic growth. Parents can remain in the workforce, contributing to local businesses and the economy at large. Moreover, children who attend high-quality child care programs are better prepared for school, setting them up for lifelong success. In this way, child care is not just a benefit for families—it's an investment in the community's future.

OPPORTUNITY 1: Understanding Child Care as Infrastructure continued

However, for child care to truly serve as critical infrastructure, we need to shift the way we view and fund it. Roads, public schools, and transportation systems all receive public investment because we recognize their value. Child care should be no different.
